

ARTICLES OF INCORPORATION OF

We, the undersigned, natural persons of the age offened. The

eighteen (18) years or more, at least two (2) of whom are Deputy Director, Corporation Division citizens of the State of Texas, acting as Incorporators of a corporation under the Texas Non-Profit Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE I.

The name of the corporation shall be Kerry Glen I Council of Co-Owners.

ARTICLE II.

The Corporation is a non-profit corporation.

ARTICLE III.

The period of its duration shall be perpetual.

ARTICLE IV.

The purpose or purposes for which the Corporation is organized are:

> To provide for the administration, management, maintenance, preservation and control of the Kerry Glen Condominium I, a condominium project located in Houston, Harris County, Texas established pursuant to the Texas Condominium Act (Texas Revised Civil Statutes Article 1301a).

To exercise and perform all of the obligations and duties of the "Council of Co-Owners" of such condominium project, as that term is used in the Texas Condominium Act.

To exercise all powers and perform all duties imposed upon this Corporation in accordance with the Declaration of Condominium of the Kerry Glen Condominium I, as such Declaration may hereafter be amended including, without limitation, to fix, levy, collect and enforce payment by lawful means of all charges or assessments affecting such condominium project; to pay all expenses in connection therewith and all expenditures incident to the conduct of the administration and business of the condominium and all licenses, franchise taxes and governmental charges levied or imposed against this Corporation or the common elements of the condominium.

In connection with the affairs of such condominium, to buy, sell and deal in real property; personal property and services and to exercise any and all other powers, rights and privileges which a corporation organized under the Texas Non-Profit Corporation Act by law now or hereafter exercised.

The aforesaid statement of purposes shall be construed as a statement of both purposes and of powers and shall be broadly construed to effectuate its intent.

ARTICLE V.

The address of the initial registered office of the Corporation is 1400 South Post Oak Road, Suite 200, Houston, Texas 77056, and the name of its initial registered agent at such address is Phylis Foster.

ARTICLE VI.

ARTICLE VIII.

Every person or entity who is a record owner of a Residence Unit or legal interest therein, in the Kerry Glen Condominium I (except those persons or entities holding an interest only as security for the performance of an obligation), and only such persons or entities, shall be Members of this Corporation. Membership in this Corporation shall be appurtenant to and may not be separated from ownership of any Residence Unit in the Kerry Glen Condominium I. Ownership of such Residence Unit or interest therein shall be the sole qualification for membership in this Corporation. The Corporation may (but shall not be required to) issue certificates evidencing membership herein.

ARTICLE IX.

These Articles of Incorporation may be amended only upon the affirmative vote of the holders of three-fourths (3/4ths) of the number of votes exercisable by the Members of this Corporation.

ARTICLE X.

The By-Laws of the Corporation may be altered, amended or repealed only by the affirmative vote of the holders of seventy-five (75%) percent of the number of votes entitled to vote upon amendment thereof.
