State of Texas, acting as incorporators of a corporation pursuant to Article 1396-3.02 of the Texas Non-Profit Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE I.

The name of the corporation is MARLBOROUGH SQUARE, SECTION I OWNERS' ASSOCIATION, INC., hereinafter known as the "Corporation".

ARTICLE II.

The Corporation is a non-profit corporation.

ARTICLE III.

The period of its duration is perpetual.

ARTICLE IV.

The purpose or purposes for which the Corporation is organized are:

To administer, enforce, and otherwise implement, in any and all ways, the maintenance and operation of Marlborough Square, Section I, a townhouse project located in Houston, Harris County, Texas, and to exercise and perform all of the functions of the Association, as that term is defined in the Declaration of Covenants, Conditions and Restrictions ("Declaration") filed for record with the

County Clerk of Harris County, Texas, under County Clerk's file number _____ on January ____, 1981.

To consent, approve, grant permission, and otherwise perform all such functions and do any and all things that may be permitted or required by the Declaration.

To promote and supervise the beautification, care, maintenance, and upkeep of such townhouse project.

In general, to carry out any other activity in connection with the foregoing and to have and exercise all the powers conferred by the laws of Texas upon non-profit corporations formed under the Texas Non-Profit Corporation Act and to do any and all things hereinbefore set forth to the same extent as natural persons might or could do.

ARTICLE V.


