II. Amendments

- A. The second sentence of Section 7.02.1 is hereby amended to read as follows:
- "Not more than two (2) Permitted Pets are allowed per Building Site unless authorized in writing by the Board or applicable Rules and Regulations, and no Permitted Pets may be raised, bred, kept or maintained for commercial purposes."
- B. Section 8.04.11 of the Declaration is hereby deleted in its entirety and the following substituted in place thereof:
 - 8.04.11 <u>Roof Materials</u>. Roofs of all residences must be constructed so that the exposed material is slate, tile, or architectural type composition shingles, or such other material which is compatible in quality and appearance to the foregoing as may be approved by the ACC. Wood shingles of any type are prohibited on any residence, building or structure.
